1. PUBLIC HEARING

REZONING: RZ-17-07-S

Altaf Cheema of Stockbridge, GA requests a rezoning from R3 (Single Family Residence) to C1 (Neighborhood Commercial) for property located at 791 Davis Rd. in Land Lots 79 and 90 of the 12th District. The property consists of 1.27 +/- acres, and the request is for a convenience store.

Ms. Moore explained the applicant is requesting a rezoning from R3 (Single Family Residence) to C1 (Neighborhood Commercial) and would like to convert their residential home to a convenient store; the County planning staff has recommended approval. Ms. Moore included most of the area has converted from residential to commercial; and, G-Dot is proposing an alignment (road widening) for the area. Ms. Moore mentioned the applicant may also try to purchase the adjacent property, however, the analysis doesn't clarify.
