

RESOLUTION NO. R17-874

**A RESOLUTION TO AUTHORIZE A COMPREHENSIVE WELLNESS PROGRAM**

WHEREAS, the City of Stockbridge ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia and is charged with being fiscally responsible concerning the use and expenditure of all public funds, and

WHEREAS, the City recognizes the tremendous benefits from utilizing a wellness program, such as health screenings and providing vital information to promote and encourage healthy living; and,

WHEREAS, staff has recommended Atlanta Health Solutions as the best vendor for this program.

THEREFORE, THE CITY COUNCIL OF THE CITY OF STOCKBRIDGE HEREBY RESOLVES:

**SECTION 1. Adoption of Wellness Program.** The wellness program provided by Atlanta Health Solutions as presented to the Council on November 13, 2017 is hereby adopted and approved for the employees of the City of Stockbridge.

**SECTION 2. Public Record.** This document shall be maintained as a public record by the City Clerk and shall be accessible to the public during all normal business hours of the City of Stockbridge.

**SECTION 3. Approval of Execution.** The Mayor is hereby authorized to sign all documents necessary to effectuate this Resolution.





The following is the renewal request for the City of Stockbridge. This is a 12 Month Wellness Program. Detailed information about each service can be found in the Strongside Solutions RFP. The minimum guarantee is 50 participants or 90% of estimated minimum number of participants, whichever is greater. The automatic renewal date for this program is September 15, 2017.

### **Atlanta Health Systems Annual Services include:**

- Program Manager to coordinate all events and arrange all logistics
- Health Screening and Health Fair
- Flu Shot Clinic
- Annual Aggregate Screening Report
- 6 onsite Wellness Lunch & Learns
- Monthly Health Coaching
- 2 Quarterly Wellness Challenges
- Health Leadership Team organized and Coordinated meeting
- Communications Director
- Monthly newsletters

### **Client responsibilities include:**

- Rooms of adequate size and lighting
- Tables, chairs, wastebaskets, electrical outlets, AV set up
- Internal promotion (AHS to supply the flyers, newsletters, meeting reminders)
- Onsite liaison at each event

Atlanta Health Systems has been requested to provide the following onsite health services to complement your employee health initiatives. This is an estimate of total costs, based upon the services listed in the Strongside Solutions RFP.

Health & Wellness Annual Program Retainer (due 10/15/16)	\$5,000.00
Health Screening and Health Fair (due 11/1/16)	\$4,000.00
Monthly service fee (due 15 <sup>th</sup> of every month)	\$1,558.33

**Term and Termination:** This agreement shall remain effective until Atlanta Health Systems has performed this annual program and City of Stockbridge has paid the service fees. If one party breaches this Agreement, the other party may terminate this Agreement prior to the end of the Term upon written notice if the breaching party fails to cure its breach. If this Agreement is terminated, City of Stockbridge shall remain obligated to pay Atlanta Health Systems for all fees and expenses incurred through the effective date of termination for services provided in a manner satisfactory for both parties.

**Indemnification:** City of Stockbridge shall indemnify, defend and hold harmless Atlanta Health Systems and its directors, affiliates, officers, agents and employees from and against any and all claim liability, loss, damage or expense, including legal fees and costs in connection with any claim, demand, action or cause of action asserted against Atlanta Health Systems because of any act or omission that arises out of or is attributed to City of Stockbridge, its employees, agents, and/or contractors provision of services and/or City of Stockbridge's failure to comply with the terms of this Agreement.

**Integration:** This Agreement constitutes the sole, full and complete agreement and understanding between Atlanta Health Systems and City of Stockbridge with respect to the matters set forth herein, and supersedes and terminates any and all prior or existing proposals, agreements, or understandings between Atlanta Health Systems and City of Stockbridge with respect to such matters.
