DCA – CDBG Project Sign

The Contractor shall supply, erect and maintain in good condition a project sign according to the specifications set forth below:

SPECIFICATIONS

Size: 4'x 8'

Materials: ¾" Marine Grade Plywood (APA rating A-B)

Supports: Pressure Treated 4" x 4" x 12' post with 2"x 4" cross branching

Erection: Post shall be set a minimum of three feet deep in concrete footings that are at least 12" in diameter

Paint: Outdoor enamel
